Yanco Offtake – improved environmental outcomes



About the Better Bidgee Program

The NSW Government is investigating a range of measures for the Murrumbidgee River system as part of rescoping the Yanco Creek Offtake Project. These measures are part of a new Better Bidgee program (the program).

Following the Murray-Darling Basin Ministerial Council meeting in April, Water Infrastructure NSW has rescoped the Yanco Creek Offtake Sustainable Diversion Limits Adjustment Mechanism (SDLAM) Project and investigated options that could be supported by the community.

Our focus over the past few months has been evaluating the years of community feedback regarding the need to improve connectivity, environmental, cultural and community outcomes.

We know that these issues can only be addressed by taking a holistic, system-wide approach to water infrastructure planning and operations, working in tandem with changes in water policy and strategy. We also know that feedback from our stakeholders and communities is critical to ensuring we progress the best options for delivering outcomes.

We have recently launched a major consultation and engagement program, which will enable us to work side-by-side with communities to investigate solutions to create a Better Bidgee. This is a shift towards beneficial outcomes for communities and the environment.

Options are currently being investigated by the project team, most of which are in the very early planning stages. Community feedback and input will play a crucial role in shaping which initiatives are progressed, and what these initiatives look like, to deliver a Better Bidgee.

About the rescoped Yanco Creek Offtake initiative

Water Infrastructure NSW has substantially revised the Yanco Creek Offtake Sustainable Diversion Limits Adjustment Mechanism (SDLAM) project, moving away from the original plan that proposed to raise the existing water level upstream of Yanco Weir by up to 2.5m under normal operating conditions.

Instead, the project is focusing on a range of smaller scale options to deliver improved operational flexibility and environmental outcomes. These options range between a 0 to 1.2m rise to the existing water level upstream of Yanco Weir under normal operating conditions.

Potential benefits

The rescoped Yanco Creek Offtake project would have significant benefits to the Yanco Creek System, as well as the broader Murrumbidgee River channel. These would include:

- increased flows to Yanco Creek
- greater control of water flows in the system
- improved fish passage and environmental outcomes
- a better balance of outcomes between Yanco Creek System and the Murrumbidgee River.
