Natural Resources Access Regulator Regulation

A guide to proposed changes to the Natural Resources Access Regulator Regulation.

The Natural Resources Access Regulator Regulation 2018 (NRAR Regulation) helps operationalise provisions of the *Natural Resources Access Regulator Act 2017*. The NRAR Regulation provides for the following:

- a. specifies as additional functions of the Natural Resources Access Regulator certain enforcement functions of the Minister under the Water Management Act 2000 in relation to costs and expenses of investigations and recovery of unpaid fees, charges and civil penalties
- b. prescribes information that may be included in the register of information about enforcement actions taken by the Natural Resources Access Regulator
- c. prescribes various agencies for the purposes of exchanging information relevant to the administration of natural resources management legislation and administration and enforcement of the *Water Act 2007* of the Commonwealth.

The new proposed NRAR Regulation is in the same terms as the current NRAR Regulation, with minor amendments to clause 7, which lists prescribed agencies for the purpose of information exchange. The proposed changes update the list to reflect current agencies and to incorporate additional agencies.
