Reconnecting River Country Program Modelling to inform decision making

Modelling plays a critical role in the development of the Reconnecting River Country Program in the Murrumbidgee and Murray River systems.

Comprehensive hydraulic modelling, checked against satellite imagery and aerial photography collected during several high flow events, has been used to develop interactive maps showing the estimated upper limits of the flow options (with buffer) being considered by the program.

Modelling for inundation mapping

This interactive mapping can be viewed at water. nsw.gov.au/rrcp-inundation-mapping. It enables landholders and other stakeholders to get a greater understanding of the periodic and low-level inundation along the proposed flow corridors that would occur during higher environmental flows.

Two types of maps are available:

- interactive, online maps of the entire program area showing the estimated upper limits of inundation associated with the flow options
- higher resolution property-scale maps are also available for potentially affected landholders via an application process. These propertyscale maps include aerial imagery, propertyscale inundation, property boundaries and infrastructure.

Improved mapping

The interactive mapping is a major improvement on previous modelling used for constraints management projects in the past and is the result of significant investment by the Australian and NSW Governments.

Development of the inundation mapping has involved an extensive data collection program providing high-quality inputs to model development and calibration, as well as desktop analysis against aerial photography and satellite imagery.

Work is underway to further ground truth and validate these provisional products with landholders and other stakeholders. The mapping will be updated and refined over time in response to this feedback.

The program's ongoing landholder and stakeholder engagement activities seek valuable feedback to further shape our mapping and inform the program's development.
