Key challenges for skills and training

DEMAND

Low uptake of accredited training in NSW water industry

No clear expectation of what training is essential to LWU

Regional utilities have difficulty attracting and retaining skilled staff

Skilled and competent operators are vital in managing drinking water quality. There is a lack of trained operators in NSW. This poses a high risk to communities.

Establish a sustainable training market for water operations

Need to address both supply and demand challenges to increase skills of existing operators, attract more operators into the sector and increase employment

SUPPLY

Lack of registered training organisations (RTOs) offering water operation training

No pathway for trainers to maintain training and technical skills

Progress against the draft skills and training action plan

- 200 fully funded training places for new water operations trainees each year were made available from December 2021
 - 80 places were filled between December 2021 and June 2022
- Quantitative analysis of workforce and training requirements for water operations in NSW
- Undertaking workforce planning pilot with Orana Water Utilities Alliance - Test regional approach to workforce planning, and operator competency and training (see also agenda item 8)
- Progressed development of business model options for the more efficient provision of training materials
- Consultation on draft of Skills and Training Action Plan, addressing both supply and demand side

Draft skills and training recommendations

From 2023, implement two-year skills and training action plan for NSW to address challenges arising from the thin market for water operators and technical skills focuses on:

- Stronger incentives to RTOs to deliver training that meet the needs of the local water utilities
- Advocacy and support to recognise water operations as a trade
- Strategies to upskill existing water operators, through part qualifications
- Investigating potential regulatory requirement for minimum competency or training requirement for water operators

Draft skills and training recommendations

Subject to negotiation with Training Services NSW and funding



Proposal to attract and retain skilled water operators at local water utilities

by:

- Continue funding of Smart and Skilled places for new operator traineeships
- Seeking funding for skills recognition and gap training of existing workers to achieve Certificate III
- Seeking funding to introduce Certificate II school-based traineeships
- Seeking funding for pre-employment skill set
- Advocate that water operations be a recognised as a trade.

Draft skills and training recommendations

Incentivise RTOs to deliver training that meet the needs of the local water utilities:

- Provide market with analysis of training gaps across regional NSW
- Make the case for higher Smart and Skilled subsidies for water operations training units, to align with trade qualifications
- Support development of quality training resources and a business model for sharing of resources
- Make the case for allowing interstate RTO to access Smart and Skilled subsidies for units of skill sets that are not currently offered by NSW RTOs
- Look at options to support RTOs to access a pipeline of accredited trainers (in DPE and utilities).

Draft skills and training recommendations



Advocacy and support to recognise water operations as a trade to help attract and retain staff in regions

- Certificate III in Water Industry Operations (NWO30219) transition to a trade qualification.
 - Make the case that water operations be listed on Federal Australian Skills Attraction Priority list
 - Make the case to increase funding under Smart and Skilled per training unit.

Recognition as a trade would help unlock funding for apprentices.

Implementing the regulatory and assurance framework - Update

Where are we at?

- Minister for Lands and Water approved framework – effective from 1 July
- Framework and “what we have heard” feedback summary published
- Works approvals (s60): interim regulatory guidance approved and published with a refinement period of 8 weeks; application portal for local water utilities is live, draft internal processes in place on 1 July and finalised by 31 July.
- Strategic planning assurance: development of guidance material and internal process progressing; engagement on transition for utilities that are developing IWCM strategies underway.
- Quality assurance framework published as draft for consultation
- Risk-based regulation training for Water Utilities team, 3 modules (June to September)
- Performance monitoring – indicator set to be finalised for consultation
- Regulator collaboration framework endorsed by all regulators



Recap - Implementation of the framework



Implemented from 1 July

- Minister approved Regulation and assurance framework for local water utilities
- Quality Assurance framework in place (draft)
- Guidance on using IP&R Framework for local water utility strategic planning published
- Relevant sections are gazetted (progressing)
- Training for Water Utilities team for risk based regulation
- Regulator collaboration framework endorsed by all regulators, publishing imminent

Section 60: Assessment and approval of works from 1 July

- Application form available online, ability to track applications 60 day 'clock'
- External guidance published for applicants
- Internal process in place for assessing and approving applications as, received
- Clarity about all applications currently with the department and a plan for transition


Strategic planning transition

- Commenced plan for engaging with each of the 40+ utilities undertaking IWCM strategies - to meet 'no disadvantage' commitment
- Guidance for each of the 12 strategic planning outcome areas by October 2022
- Assurance of strategic planning fully implemented by 1 December


Regional collaboration pilots - update

- Involving Orana Water Utilities Alliance Councils (Bogan, Bourke, Brewarrina, Central Darling, Cobar, Coonamble, Gilgandra, Mid-Western, Narromine, Walgett, Warren and Warrumbungle Councils)

Remote technology pilot Bourke and Cobar councils

- Being delivered by Veolia.
- The Water Utilities team are separately trialling remote headsets in their work with local water utilities.
