Explanatory note

This Order is made under section 59 (1) (a) of the *Water Management Act 2000*. The object of this Order is to make an available water determination for various categories and subcategories of access licences in the water sources identified in Schedule 1.

1 Name of Order

This Order is the Available Water Determination Order for the Regulated Rivers in the Richmond River Area Unregulated, Regulated and Alluvial Water Sources, and Bega and Brogo Rivers Area Regulated, Unregulated and Alluvial Water Sources 2020.

2 Commencement

This Order commences on 1 July 2020.

3 Available water determination

This Order determines the availability of water for take from a regulated river in each water source specified in Schedule 1, for the categories and subcategories of access licences specified in Schedules 2, 3, 4, 5, 6 and 7, on the terms specified in the corresponding schedules.

<u>Note</u>: An available water determination made in relation to a particular category of access licence applies to all subcategories of that category, except to the extent to which this order provides otherwise, in accordance with section 59 (1A) of the *Water Management Act 2000*.

Schedule 1 Water sources

This Order applies to the following water sources:

- **1.** All regulated river water sources to which the *Water Sharing Plan for the Richmond River Area Unregulated, Regulated and Alluvial Water Sources 2010* applies; and
- 2. All regulated river water sources to which the Water Sharing Plan for the Bega and Brogo Rivers Area Regulated, Unregulated and Alluvial Water Sources 2011 applies.

Schedule 2 Domestic and stock access licences

Each amount specified in Column 2 applies to domestic and stock access licences with a share component that specifies the adjacent water source specified in Column 1.
