#### **Explanatory note**

This Order is made under section 59 (1) (a) of the *Water Management Act 2000.* The object of this Order is to make an available water determination for various categories and subcategories of access licences in the water sources identified in Schedule 1.

## Available Water Determination Order for NSW Groundwater Sources 2020

#### 1 Name of Order

This Order is the Available Water Determination Order for NSW Groundwater Sources 2020.

#### 2 Commencement

This Order commences on 1 July 2020.

#### 3 Available water determination

This Order determines the availability of water for take from an aquifer in each water source specified in Schedule 1, for each category or subcategory of access licence specified in Schedules 2 and 3, on the corresponding terms specified in those schedules.

<u>Note</u>: An available water determination made in relation to a particular category of access licence applies to all subcategories of that category, except to the extent to which this order provides otherwise, in accordance with section 59 (1A) of the *Water Management Act 2000*.
