## 1 Name of Order

This Order is the Available Water Determination Order for the Murrumbidgee Regulated River Water Source 2020-21 [No. 1].

## 2 Commencement

This Order commences on the $15^{\text {th }}$ of July 2020

## 3 Available water determination

This Order determines the availability of water in relation to the water source specified in Schedule 1, for the categories and subcategories of access licence specified in Schedules 2, 3, 4 and 5 on the terms specified in Schedules 2, 3, 4 and 5.

## Schedule 1 Water sources

This Order applies to the following water sources:

1. all water sources to which the Water Sharing Plan for the Murrumbidgee Regulated River Water Source 2016 applies;
