Explanatory note

This Order is made under section 59 (1) (a) of the *Water Management Act 2000*. The object of this Order is to make an available water determination for various categories of access licences in the water sources identified in Schedule 1.

1 Name of Order

This Order is the *Available Water Determination Order for the Hastings Unregulated and Alluvial Water Sources 2019*.

2 Commencement

This Order commences on 1st July 2019.

3 Available water determination

This Order determines the availability of water in relation to the water sources specified in Schedule 1 and 4, for the categories and subcategories of access licence specified in Schedules 2 and 5, and 3 and 6, on the terms specified in Schedules 2 and 5, and 3 and 6.

Schedule 1 Water Sources

This Order applies to all Hastings Unregulated and Alluvial water sources to which the *Water Sharing Plan for the Hastings Unregulated and Alluvial Water Sources 2019* applies.

Schedule 2 Category of access licence

Each amount specified in Column 2 applies to the adjacent category/ subcategory of access licence specified in Column 1.

This Order applies to all Hastings River Coastal Floodplain Alluvial Groundwater sources to which the *Water Sharing Plan for the Hastings Unregulated and Alluvial Water Sources 2019* applies.

Each amount specified in Column 2 applies to the adjacent category/ subcategory of access licence specified in Column 1.
