## **Explanatory note**

This Order is made under section 59 (1) (a) of the *Water Management Act 2000*. The object of this Order is to make an available water determination for various categories of access licences in the water sources identified in Schedule 1.

## 1 Name of Order

This Order is the *Available Water Determination Order for Various NSW Regulated River Water Sources (No. 2) 2019*.

## 2 Commencement

This Order commences on 1 July 2019.

## 3 Available water determination

This Order determines the availability of water in relation to the water sources specified in Schedule 1, for the categories and subcategories of access licence specified in Schedules 2, 3, 4, 5, 6, 7, 8, 9, 10, and 11 on the terms specified in Schedules 2, 3, 4, 5, 6, 7, 8, 9, 10, and 11.

### Schedule 1 Water sources

This Order applies to the following water sources:

1. All water sources to which the *Water Sharing Plan for the Belubula Regulated River Water Source 2012* applies;
2. All water sources to which the *Water Sharing Plan for the Lachlan Regulated River Water Source 2016* applies;
3. All water sources to which the *Water Sharing Plan for the Macquarie and Cudgegong Regulated Rivers Water Source 2016* applies;
4. All water sources to which the *Water Sharing Plan for the Murrumbidgee Regulated River Water Source 2016* applies;
5. All water sources to which the *Water Sharing Plan for the New South Wales Murray and Lower Darling Regulated Rivers Water Sources 2016* applies.

## Schedule 2 Domestic and stock access licences

Each amount specified in Column 2 applies to domestic and stock access licences with a share component that specifies the adjacent water source specified in Column 1.
